Full Membership of the Wilton CLT requires the purchase of a share to the value of £1 (one Pound).

Application for Associate Membership is open to:

 Any individual over the age of 16 who supports the objects of the Trust and agrees to be bound by its Rules. Associate Members are not required to purchase a £1 share but are asked to make a donation.

To become a Full Member or an Associate Member, application should be made in writing to the Trust's Registered office accompanied by the £1 share purchase price or donation. An application form is provided as part of this leaflet.

When considering applications for membership, the Board will consider each application on its merits having regard to:

- · The Rules of the Society
- Potential conflicts of interest
- Whether applications are Board Members or paid staff of other Community Land Trusts.
